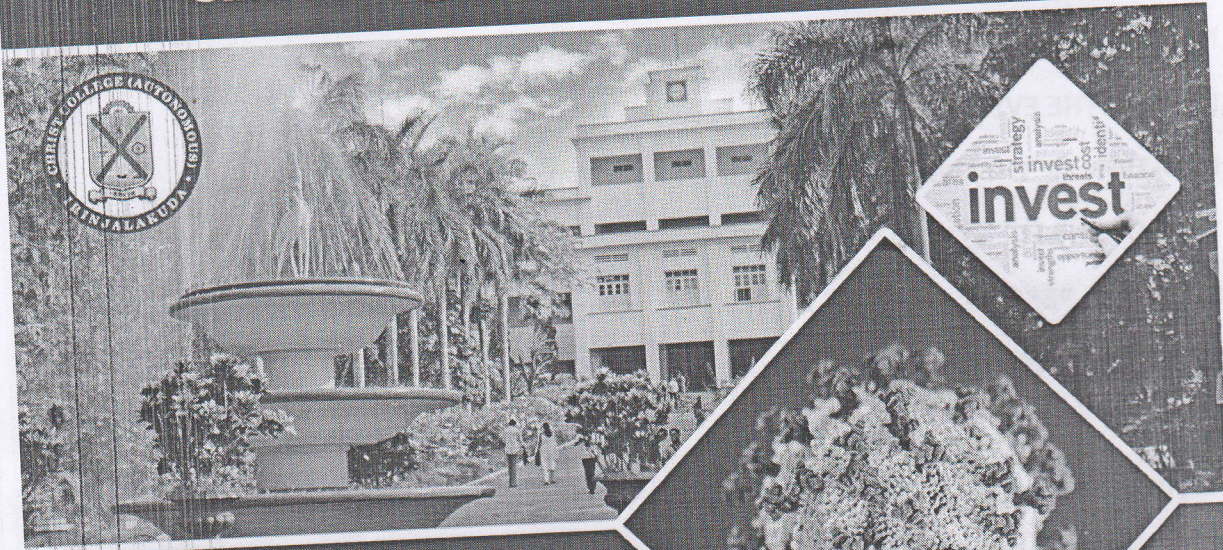
Program:
