The minutes of the meeting held on 27 June 2022 at 2:00 p.m. in the conference hall.




Agenda:-





Agenda:-

To evaluate the performance of the discipline committee for the academic year 2022-2023.


Discussions Made:-




Agenda: To discuss the disciplinary action against 8 students in their involvement in disrupting the peaceful atmosphere of the campus.
