


## MEMORANDUM OF UNDERSTANDING

Dr. Jolly Andrews CMI** (Hereinafter called as the second party which expression shall include his successors and assignees in the office).

Whereas it is mutually decided to enter into a Memorandum of Understanding wherein the obligations, terms, responsibilities and rights of both the parties are contained.

1. The First Party and the Second Party together shall try to empower the students through some of the programmes mentioned below:
  - To organize workshops, seminars, conferences, symposia etc. to expose the students to the latest developments in management science and practices.
  - To provide mentoring service to prospective entrepreneurs to hatch out their bright ideas into sustainable business models with substantive value for the society.
  - To establish business incubators in campuses to provide business support services to start-ups.






- To organize industrial visits to familiarize the students with the working environment and management practices of various categories of industries.
- To impart training in interview and GD skills to make the students ready for recruitments.
- To organize job fairs in collaboration with potential employers.
- To conduct surveys and publish reports to influence policy making.
- Participation certificate to all student chapter members, at the end of the academic session.
- Discounted fee for attending various training workshops/courses.
- Opportunities to work in TMA as an intern during the major conventions/flagship events.
- Best Student Chapter Award.

2. The Second Party shall execute the following mentioned details:

- Collect the fees fixed from time to time.
- Coordinate with the students.
- To manage all the affairs of the Chapter, to incur and meet all necessary expenses and to do all such acts as are not inconsistent with the byelaws.
- To chalk out member-centric programmes for each year.
- To maintain the Register of Members of the Chapter.
- To hold a meeting of the Committee once in 3 months or whenever deemed necessary.
- The Head of the Institution or the Director of the Course shall be the Patron of the Chapter.

- A Staff Coordinator nominated by the Head of the Institution/Director of the Course shall oversee the functioning of the Chapter.
  - Besides the Patron and Staff Coordinator, the Committee shall have 4 members who shall be selected as President, Sr.Vice President, Secretary / Student Coordinator and Joint Secretary / Joint Student Co-coordinator.
3. Any disputes arising between the parties with respect to the conduct of the program shall be resolved by mutual discussion.
- This Memorandum / Agreement is not a contract. This Memorandum / Agreement serves only as a statement of the general intention of the parties and is not intended to be legally binding nor to be construed as an agreement on any matters mentioned. No oral agreement or conduct of the Parties (including partial performance) in respect of matters stated in this Memorandum / Agreement shall be deemed to impose any obligation or liability on either Party.
  - Either party may request changes to this MOU. Any changes, modifications, revisions or amendments to this MOU which are mutually agreed upon by and between the parties to this MOU shall be incorporated by written instrument, and effective when executed and signed by all parties to this MOU.
