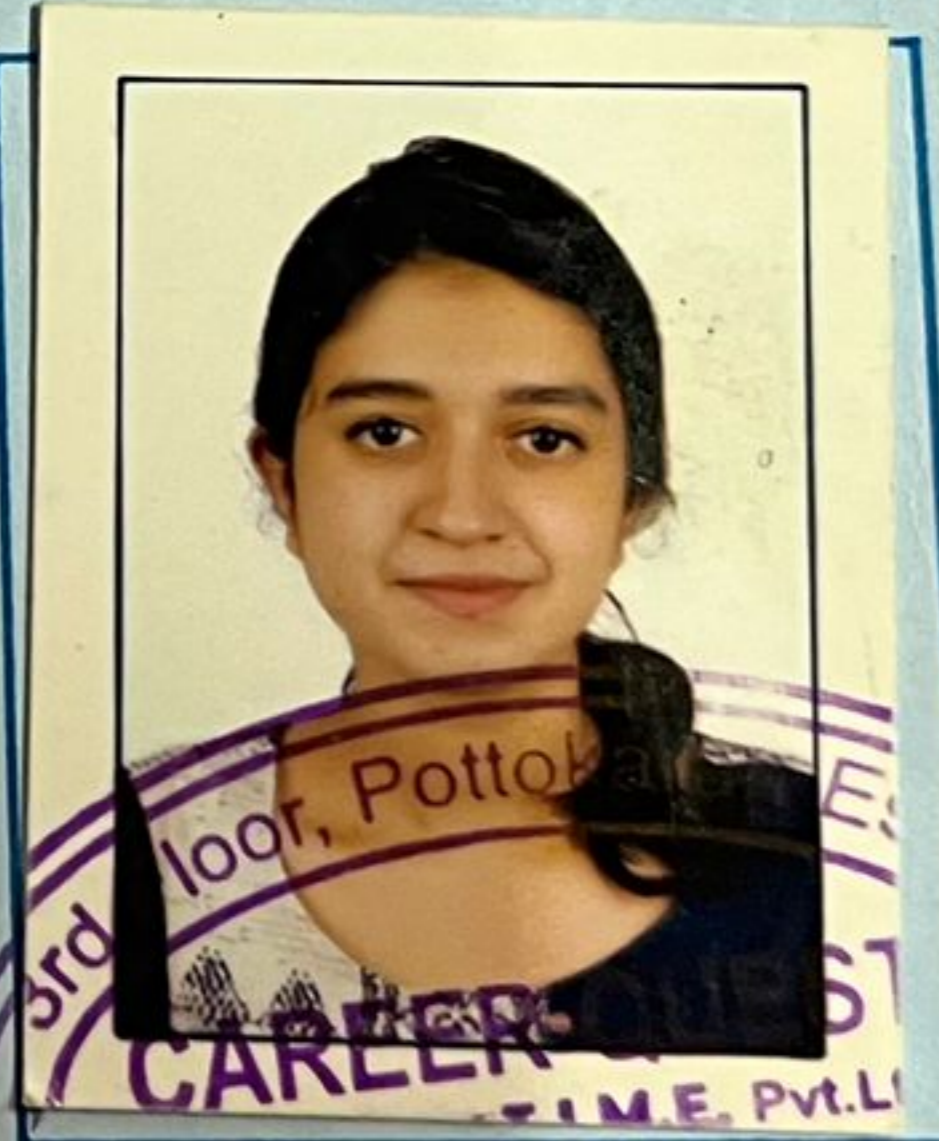

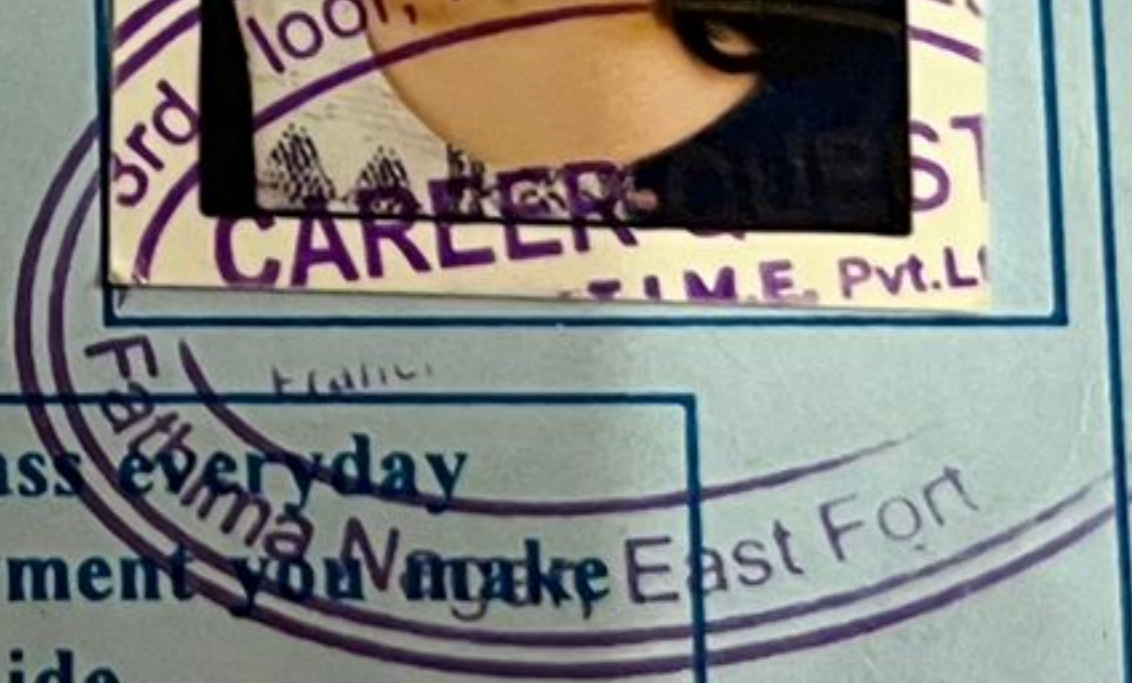

11. Admitted candidates will have to make an organization study given by the department and submit the report on the first day of the class.
