# <u>CHAPTER -1</u> <u>INTRODUCTION</u>

Nomophobia as the fear of being out of mobile phone contact, and the anxiety produced by the thought of losing it or being unable to use it (Kim and Kang, 2013).

A phobia is an excessive and irrational fear reaction. If you have a phobia, you may experience a deep sense of dread or panic when you encounter the source of your fear. The fear can be of a certain place, situation, or object. Unlike general anxiety disorders, a phobia is usually connected to something specific. The impact of a phobia can range from annoying to severely disabling. People with phobias often realize their fear is irrational, but they're unable to do anything about it. Such fears can interfere with work, school, and personal relationships. With the changes of technologies, new challenges are coming up on a daily basis. New kinds of phobias have emerged (the so-called techno-phobias). Since the first mobile phone was introduced to the consumer market in 1983, these devices have become significantly mainstream in the majority of societies. An estimated 19 million of people have a phobia that causes difficulty in some area of their lives. Seek the help of your doctor if you have a fear that prevents you from leading your fullest life.

Nomophobia (short for "no mobile phobia") is a word for the fear of, or anxiety caused by, not having a working mobile phone. It has been considered a symptom or syndrome of problematic digital media use in mental health, the definitions of which are not standardized for technical and genetically reasons. Other mental disorders like, social phobia or social anxiety, and panic disorder may also precipitate Nomo phobic symptoms. It is very difficult to differentiate whether the patient become Nomo phobic due to mobile phone addiction or existing anxiety disorders manifest as Nomophobia symptoms. The signs and symptoms are observed in Nomophobia cases includeanxiety, respiratory alterations, trembling, perspiration, agitation, disorientation and tachycardia. Nomophobia may also act as a proxy to other disorders. So, we have to be very judicious regarding its diagnosis. Some mental disorders can precipitate Nomophobia also and vice versa. The increasing dependence and obsession that people experience in relation to their mobile phones have resulted in the rise of a new phobia  nomophobia – which is the extreme and overwhelming fear of being without your mobile phone.

The term, "NOMOPHOBIA," was coined by the United Kingdom (UK) Post Office in 2008 during a study who commissioned You Gov, a UK-based research organization. The objective of that study was to evaluate the possibility of anxiety disorders occurred due to overuse of mobile phones. The study found that nearly 53% British who used mobile phones, pretend to be apprehensive when they "lose their mobile phone, run out of battery or credit, or have no network coverage". That study also revealed that approximately 58% of male and 47% of female suffered from the mobile phone anxiety, and additionally 9% felt strained when their mobile phones were switched off. 55% of the participants agreed that they are not able to maintain connectivity with their dear and near one, which was the main reason for their phobia. On comparing the stress levels it was found that the anxiety level was at-par with those of "wedding day jitters."

Phone addiction is the compulsive overuse of a mobile phone, where someone fears not having their mobile phone with them or not being able to send or receive messages. Many of those addicted to their phones experience phantom vibrations - the phenomenon of thinking that your phone is vibrating from a notification when it actually is not. A study found that many students today display addictive mobile phone behaviour, where they spend a whopping average of 8 10 hours per day on their phones. Recent research shows that 47% of teenagers use their phones whilst on the toilet, and 81% of people never turn their phone off – even when in bed. Although mobile phones can be a great tool to help people connect with each other, spending too much time on it can reduce concentration, decrease quality of sleep and, crucially, negatively impact academic performance. Over-usage of cell phones may increase anxiety due to the pressure to be continually connected to social networks and could rob chances of perceived solitude, relieving daily stress, that has been linked as a component of wellbeing. People can use mobile phones to connect with friends and family, to obtain interpersonal needs such as family affection and tolerance. Mobile phones can also allow users to get support and accompany on the Internet. People indeed use mobile phones to regulate emotions, and as a powerful tool for cyber-psychology, mobile phones are connected to people's emotional life.

The most common psychological consequences of nomophobia are anxiety, depression or isolation –mobile phones are thought to keep us in touch with others, but the problem arises when online relationships replace face-to-face ones. There are also physical consequences such as headaches, stomach aches, eye discomfort due to overexposure to the screen, or wrist and neck pain due to improper positioning.

Mental distress or psychological distress encompasses the symptoms and experiences of a person's internal life that are commonly held to be troubling, confusing or out of the ordinary. Mental distress can potentially lead to a change of behaviour, affect a person's emotions in a negative way, and affect their relationships with the people around them .Those who are members of vulnerable populations might experience discrimination that places them at increased risk for experiencing mental distress as well. This may be something which resolves without further medical intervention, though people who endure such symptoms longer term are more likely to be diagnosed with mental illness. This definition is not without controversy as some mental health practitioners would use the terms "mental distress" and "mental disorder" interchangeably. Some users of mental health services prefer the term "mental distress" in describing their experience as they feel it better captures that sense of the unique and personal nature of their experience, while also making it easier to relate to, since everyone experiences distress at different times.

Currently, access to the Internet through smartphones has led to their functions going beyond purely communicative ones, allowing the management of massive, instantaneous, and easily accessible information. More and more young people are acquiring a smartphone at an early age (1–4 years). Home confinement by COVID-19 imposed the need to adapt to the new reality using technology to ensure that private and working life could continue under health restrictions. Smartphones, more than ever, have been an excellent tool for communication and information management, which has boosted the use of these devices in all areas of daily life. The present study extends the existing literature on nomophobia by providing results of interest in terms of gender and the exceptional healthcare context of COVID-19. The results suggest that despite intense daily smartphone use young people did not reach severe nomophobia figures. This fact underlines the need for appropriate and healthy technology education. Understanding the characteristics of the populations that use the smartphone the most may help to analyse nomophobia rates and the massive use of the device.

In this study "A study on nomophobia among the students of Christ College (Autonomous) Irinjalakuda" aim to find out whether there is nomophobia among the students of Christ College (Autonomous) Irinjalakuda. Recognizing a problem is critical for solving it, so recognizing the status of nomophobia can help us make the necessary interventions to address the emerging non- drug addictions of the 21st century.

# <u>CHAPTER-2</u> <u>REVIEW OF LITERATURE</u>

(Ashvneet Kaur, 2021)Nomophobia and social interaction anxiety among university students proved that of majority of the students (55.50%) were 14-16 years old when they owned their first smartphone, followed by 30.62% students in the age group of 17– 19 years, 8.13% students in the age group of 11-13 years, 3.83% students in the age group of 20-21 years and even 1.91% students in the age group of 8-10 years. Most of the students (52.15%) had no social interaction anxiety, whereas 40.19% suffered from probable social phobia, followed by 7.66% who suffered from probable social anxiety. All the students were nomophobic and had different levels of nomophobia. The majority of the students, i.e., 118(56.5%), were moderately nomophobic, and 74(35.4%) were severely nomophobic, whereas only 17(8.1%) were mildly nomophobic. There was a significant association of nomophobia with the department of study, family income per month, working status of parents, and the age at which smartphone ownership was obtained, and time in hours per day spent on using a smartphone. .66% who suffered from probable social anxiety. Nomophobia and social interaction anxiety were found to have a weak positive correlation. The students having higher social interaction anxiety scores had higher scores on nomophobia

(MB Pavithra, 2015) A study on nomophobia-mobile phone dependence, among students of a medical college in Bangalore, the study population of 200 students comprised of 47.5% females and 52.5% males. Majority (74%) of the students spent Ru-pees 300-500 per month on mobile recharge. About 23% students felt they lose concentration and become stressed when they do not have their mobile around, 79 (39.5%) students were Nomopobic in this study and another 27% were at risk of developing Nomophobia .The study is indicative of increasing prevalence of Nomophobia among younger generation. Further research and multi-centric studies are required to investigate more in depth the psychological aspects and solutions for nomophobia.

(G jilisha, 2019) The study of Nomophobia: A mixed-methods study on prevalence, associated factors, and perception among college students in Puducherry, India.

Resulted that 774 participants, 23.5% had severe nomophobia scores. Older age, male gender, duration and frequency of smartphone usage, use for social networking, checking without reason, and checking smartphone after waking up in the morning were significantly associated with nomophobia. The in-depth interview showed attributes of addiction among the students, like dependency and compulsive behaviour. Students also experienced anxiety and frustration when they had to part with their smart phones. Duration of smartphone usage was found to be 3–6 hours in nearly half of the participants (52.1%), and 19% of the participants even reported using their smartphone for 7 hours and more per day. Nearly 38% felt that their smartphone use was hampering their academic performance, and 55% said that they check their smartphones as soon as they get up in the morning. Out of 774 responses from participants, the highest proportion of perceived ill health effect due to smartphone use was reported for headache (23.6%), followed by eye strain (21.8%)A sizable minority of the students had signs of severe nomophobia, distinct patterns of usage, and misperceptions regarding health.

(Sethia et al., 2018) A study on nomophobia-mobile phone dependence, among students of a medical college in Bangalore. Study population of 200 students comprised of 47.5% females and 52.5% males. Majority (74%) of the students spent Rupees 300-500 per month on mobile recharge. About 23% students felt they lose concentration and become stressed when they do not have their mobile around, 79 (39.5%) students were Nomophobic in this study and another 27% were at risk of developing Nomophobia. The result of our study is indicative of increasing prevalence of Nomophobia among younger generation. Further re-search and multi-centric studies are required to investigate more in depth the psychological aspects and solutions for nomophobia.

(Madhusudan Muralidhar, 2017) A research conducted on Nomophobia and its determinants among the students of a medical college in Kerala, The grades of nomophobia showed a no statistically significant association with sex, admission quota whereas stati .The prevalence of nomophobia was 97%. The grades of nomophobia showed no statistically significant association with sex, admission quota, and residence whereas statistically significant association with phase of the MBBS) with highest prevalence among phase II students. 99.06% students were using smart phones for calling family members, 91.84% for calling friends and 88.57% for listening to music

stically significant association with phase of the MBBS (P = 0.001) with no nomophobia. There was high prevalence of nomophobia among the students of the medical college. Nomophobia was not found to be associated with sex, quota of admission, place of origin, and place of stay. The most common reasons for smartphone use were calling of family members.

(Caglar Yildirim, Evren Sumuer, Müge Adnan, Soner Yildirim) 'A growing fear: Prevalence of nomophobia among Turkish college students'. The purpose of the study was to investigate the prevalence of nomophobia (the fear of being out of mobile phone contact) among young adults in Turkey. The Nomophobia Questionnaire (NMP-Q) was administered to 537 Turkish college students. The study employed a causalcomparative research design. Convenience sampling is used in this for the purpose of sampling. The results of the study revealed that 42.6% of young adults had nomophobia, and their greatest fears were related to communication and information access. The study also found that gender and the duration of smartphone ownership had an effect on young adults' nomophobic behaviours, whereas age and the duration of mobile phone ownership had no effect.

(Dony Darma Sagita, Fatma Santika, 2021) conducted a study on 'Nomophobia in adolescents based on gender: a case study of East Jakarta, Indonesia' In this study they state that Nomophobia is a modern phobia that occurs mostly in adolescents due to addiction to the use of a smartphone. The purpose of this study is to analyse the differences in the level of nomophobia among adolescents based on gender and it was a quantitative research with a comparative descriptive approach. Data were obtained from 400 adolescents selected using the convenience sampling technique. The instrument used was the Indonesian version of the Nomophobia Questionnaire (NMP-Q) was used to assess nomophobia. Beck's Depression Inventory (BDI), Beck's Anxiety Inventory (BAI), and Short Form-36 (SF-36) were used to measure depression, anxiety, and quality of life, respectively. A cross-sectional study was carried out in 1386 high school students aged between 14 and 17 years. Out of 1386 adolescents, 569 (41.05%), 303 (21.86%), and 82 (5.1%) have mild, moderate, and severe nomophobia, respectively. There were significantly more males with nomophobia. There was a statistically significant relationship between NMP-Q score and BDI, BAI, and SF-36 scores. A significant positive correlation was observed between NMP-Q score and scores on BDI and BAI and a significant negative correlation between SF-36 score. The results of the study indicate that nomophobia is an emerging mental health condition, especially in male adolescents. Nomophobia is significantly associated with depression, anxiety, and poor quality of life. Multi centric studies are needed to better understand this disorder.

(Burhanettin, Ozdemir, Ozlem Cakir, Irshad Hussain, 2018)Prevalence of Nomophobia among university students: A comparative study of Pakistani and Turkish undergraduate students was a study conducted by This study focused on to examine prevalence of nomophobia among university students; and the relationship among nomophobia, self-esteem, loneliness and self- happiness with respect to gender and year of study of the university students in Pakistan and Turkey. The study subjects consisted of 729 students 368 (50.5%) of which were from Turkey and 361 (49.5%) from Pakistan. The data were collected by using Nomophobia Scale (NMP-Q), UCLA Loneliness Scale (ULS-8), Self-Happiness Scale, and Rosenberg' Self-Esteem Scale by the researchers from Pakistan and Turkey respectively. The relationship and the effect of each psychological structure on nomophobia were examined with multiple linear regression model. The difference across the categories of independent variables on each of the dependent variables (loneliness, self-happiness, self-esteem and nomophobia) and on linear combination of dependent variables for each country was examined by multivariate MANOVA. According to multivariate effects results, the main effect of gender on self-esteem and nomophobia was statistically significant which indicates that differences between male and female students with respect to self-esteem and nomophobia were significant. The study demonstrated differences between Turkish and Pakistani students' score on nomophobia, loneliness and self-happiness were significant, while difference on self-esteem across countries was not statistically significant.

(Sudip Bhattacharya, Md Abu Bashar, Abhay Srivastava, Amarjeet Singh, 2019) Nomophobia: No mobile phone phobia a study .In this study they describe about what is nomophobia, which are the various psychological factors causing nomophobia, its after effects, signs and symptoms and significant of related studies in this field. According to this study the term NOMOPHOBIA or NO Mobile Phone Phobia is used to describe a psychological condition when people have a fear of being detached from mobile phone connectivity. The term NOMOPHOBIA is constructed on definitions described in the DSM-IV, it has been labelled as a "phobia for a particular/specific things". Various psychological factors are involved when a person overuses the mobile phone, eg, low self-esteem, extrovert personality. The burden of this problem is now increasing globally. Other mental disorders like, social phobia or social anxiety, and panic disorder may also precipitate nomophobic symptoms. It is very difficult to differentiate whether the patient become nomophobic due to mobile phone addiction or existing anxiety disorders manifest as Nomophobic symptoms. The signs and symptoms are observed in NOMOPHOBIA cases include-anxiety, respiratory alterations, trembling, perspiration, agitation, disorientation and tachycardia. NOMOPHOBIA may also act as a proxy to other disorders. So, we have to be very judicious regarding its diagnosis. Some mental disorders can precipitate Nomophobia also and viceversa. The complexity of this condition is very challenging to the patients' family members as well as for the physicians as Nomophobia shares common clinical symptoms with other disorders. That's why Nomophobia should be diagnosed by exclusion. We have to stay in the real world more than virtual world. We have to reestablish the human-human interactions, face to face connections. So, we need to limit our use of mobile phones rather than banning it because we cannot escape the force of technological advancement.

(Mohammad Darvishi, Majid Noori, Mohammad Reza Nazer, Soheil Sheikholeslami, Ebrahim Karimi, 2019)Investigating different dimensions of nomophobia among medical students: a cross-sectional study .This aimed to investigate nomophobia (no mobile phone phobia) among medical students of Islamic Azad University, Tehran Branch. This descriptive cross-sectional study was conducted on 100 students studying in different majors of medical sciences in Islamic Azad University, Tehran Branch, from 2016 to 2017. Demographic data of all participants were recorded in a data sheet. In the next stage, a questionnaire was designed by the researcher to evaluate the effect of age, gender, education, and the duration of using cell phone variables on discomfort, anxiety, and insecurity due to lack of access to cell phone or other related issues. Raw data were analysed using SPSS statistical software version 21. The significance level was considered P < 0.05. The results of the study showed that participants with lower mean age felt more discomfort, anger, anxiety, and insecurity due to lack of access to mobile phones and other related issues compared to other people. However, no variable was statistically significant (P-value>0.05). Except anxiety, results showed that longer duration of mobile phone use might lead to a

significant decrease in discomfort, anger, and insensibility variables among users (P-value> 0.05). The incidence of nomophobia (with its different aspects) was significantly lower in females (P-value> 0.05). Also, in participants with higher educational status, the nomophobia was recorded to be more frequent (P-Value> 0.05).

# <u>CHAPTER -3</u> RESEARCH METHDOLOGY

#### Title of the study

A study on nomophobia among the students of Christ College [Autonomous] Irinjalakuda

#### Statement of the problem

The problem of nomophobia is characterized by the mental stress feel when separated from Mobile phone which affect college students .This issue has become increasingly prevalent in this modern technological era leading to serious health problems. Understanding and addressing nomophobia is crucial because it can significantly impact individuals overall wellbeing and daily functioning.

#### Significance of the study

This study aimed to find out how common nomophobia was among college students and to understand its severity. Knowing the extent of the problem helped to address it more effectively. The study sought to determine if nomophobia significantly affected students. If it did, then those in charge could take steps to quickly fix the problem. By investigating this issue, authorities would be able to figure out who needed help and what kind of help they required. It was important because nomophobia could make it hard for students to focus on their studies and enjoy their time at college. Once this study determined how many students were dealing with this issue and how severe it was for them, a plan could be made to improve the situation.

#### Objective

1. To asses nomophobia among the respondents.

#### Specific objective

- 1. To find out the socio-demographic profile of the respondents
- 2. To assess the mental stress among the respondents due to nomophobia

#### Definitions

#### Conceptual definition

\* Caglar Yildirim and Ana-Paula Correia (2015): Nomophobia is defined as "the fear of losing one's connection to the virtual world represented by the mobile device."

\* John Dewey (1916): defined a student as "an active participant in the learning process who interacts with their environment to construct knowledge."

\*Mental stress: A form of stress that occurs because of how events in one's external or internal environment are perceived, resulting in the psychological experience of distress and anxiety (Lazarus & Folkman, 1984).

\* Glen H. Elder Jr. (1983): Elder described sociodemographic factors as "the social and demographic attributes, such as age, gender, ethnicity, education, income, and marital-status that characterize a population."

#### Operational definition

\*Nomophobia: Nomophobia is a term used to describe the fear or anxiety that people experience when they are unable to use their mobile phones or other digital devices, particularly smartphones.

\*Student: Student refers to individuals pursuing a final year under graduation degree from Christ College [Autonomous] Irinjalakuda.

\*Mental stress: It refers to the fear or anxiety that individuals experience when they are unable to use or access their mobile phones. Mental stress faced by a nomophobic person includes feelings of unease, anxiety, and distress when separated from their phone, as well as the fear of missing out on important information or communication.

\*Socio-demographic: Socio-demographic are characteristics of respondents. Generally, characteristics such as age, gender, education level, location etc.

#### **Pilot study**

The researcher did interaction with the research guide to know the feasibility of the research.

#### **Research Design**

The research design of the study is descriptive in nature because this study involve gathering data and describe a phenomenon called nomophobia.

## Universe/ Population of the study

The population under investigation in this study includes all final year UG student of Christ College (Autonomous) Irinjalakuda who own a mobile phone.

## Unit of the study

## \*Sample unit

A final year UG student of Christ College (Autonomous) Irinjalakuda, who own a mobile phone.

## \*Sample size

Researcher collected the data from 60 respondents.

## \*Inclusion criteria

All final year UG students of Christ College (Autonomous) Irinjalakuda, who own a mobile phone.

## Sampling

1. Sample design: Probability sampling

2. Sample method: Simple random method will be designed used for selecting sample.














































Distribution of respondents based on age

The above figure 23 shows the distribution of respondents based gender, the majority of the respondents identified as females (61.3%), followed by (37.1%) identified as males and a small proportion (1.6%) falls under the others category.

#### **CHAPTER -5**

#### FINDINGS, SUGGESTIONS AND CONCLUSION

#### **Findings:**

The study's findings shed light on the prevalent issue of nomophobia among college students, revealing a significant 68% demonstrating a moderate level of concern and dependency on their mobile devices. This underscores the need for interventions to address potential negative impacts on mental health due to excessive smartphone usage.

Furthermore, the data show that 21% experience a milder form of nomophobia, while 11.3% report severe levels, highlighting the diverse responses to mobile technology within the college demographic. These statistics emphasize the nuanced nature of nomophobia and the varying degrees of distress it can cause among students.

Of note is the absence of students displaying no signs of nomophobia, indicating the pervasive influence of mobile technology in college life. This suggests that virtually all students are affected to some extent by nomophobia, influencing their daily routines, social interactions, and overall well-being.

The findings also reveals that the majority of the respondents, comprising 74.2%, fall within the 20 years of the age. Additionally, a significant proportion, accounting for 61.3%, identify as female.

#### **Suggestions :**

- Colleges can include lessons about healthy tech habits, stress management, and taking breaks from screens in their curriculum. These lessons help students learn to use smartphones responsibly and maintain a healthy balance with technology.
- Colleges can create tailored support programs, like counselling and workshops, to help students with different levels of nomophobia. These programs offer practical strategies for managing smartphone use.
- 3. Encouraging students to participate in activities away from screens and to interact in person can lessen their reliance on mobile devices. Hosting campus

events and social gatherings that encourage face-to-face interactions offers students chances to find a balance between online and offline activities.

- 4. Setting up areas on campus where technology is not allowed, like libraries and study areas, gives students a break from always being connected. These zones provide students with quiet spaces to focus on their work or relax without interruptions from their devices.
- 5. It's important for colleges to keep studying how nomophobia and digital tech affect students' mental health.

#### Social work implication:

- Social casework can conduct individualized case work to assist college students in breaking free from the trap of nomophobia.
- We can conduct group interventions to help individuals overcome nomophobiarelated issues through social group work.
- Social workers can engage in community organization efforts to support students experiencing different levels of nomophobia.
- Social work research can be utilized to explore correlations between various variables, such as nomophobia, academic performance, focus, and social anxiety, providing further insights.

#### **Conclusion:**

"A study on nomophobia among the students of Christ college (autonomous) Irinjalakuda" reveals that nomophobia is widespread among college students, with 68% showing moderate levels of concern. This highlights the urgent need for interventions to address excessive smartphone use and its impact on mental health. Additionally, 21% experience milder nomophobia, while 11.3% report severe cases, indicating varying responses to mobile technology. The absence of students without nomophobia suggests its pervasive influence on college life. Therefore, targeted interventions are necessary to mitigate its negative effects. By understanding the relationship between mobile technology and mental health, educators and mental health professionals can develop strategies to promote healthier smartphone habits and improve overall well-being among students. Further research is needed to better understand and address nomophobia in college settings.
