Social work trainee completed 20 days of agency based fieldwork in Prime educational and social trust, Pondicherry. Field works are important for a social work trainee, as it helps the trainee to practice their knowledge and enrich their experience. The social work trainee learned a lot during this 20 days of agency based fieldwork.

OBJECTIVIES

2. To develop the ability to involve the client system in the problem solving process, utilizing skills of social work interventions
3. To enable to acquire knowledge and practice skills related to social work methods in different fields

6. To reinforce the belief in the inherent strength of the people to meet their needs and resolve their problems

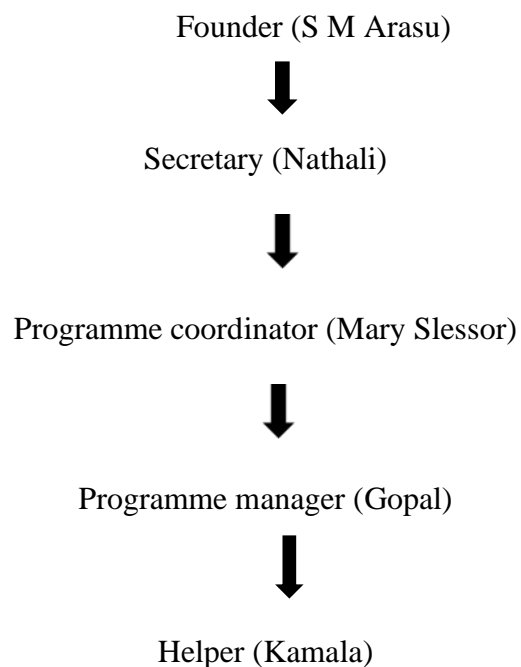

ACTIVITIES

- **Awareness class**

Social work trainee took awareness class for the children of Janani home (it's a home for girls)on 8th December 2023 based on Human rights in accordance to human rights day. Trainee mainly focused on child rights such as importance of education and protection of the child. By this trainee was able to convey the based idea about the rights of a child to the children.

- **Workshop**

Social work trainee conducted a workshop on how to make posters for the children of Janani home on 8th December 2023. For that trainee divided the children into different groups and taught the children how to make posters and each team made two posters. Through this workshop, the children learned that making posters is important to educate the public about any issue.

- **Day observation**

Social work trainee organized and observed human rights day and conducted rally around the streets of Janani home and also distributed brouchers, on 9th December 2023.

- **Project proposal**

The trainee identified that lack of community sanitation in Pondicherry, so trainee wrote a project proposal on the title "COME LET'S CLEAN OUR PONDY" which is a project aims to address the community sanitation related issues such as lack of drainage cleaning, increasing number of stray dogs.... Etc. And also aims to aware the people for Importance of community sanitation and implement various activities for achieving this aim like to improve sanitation facilities, to observe a day in a week as dry day and so on. It will help them to make their live better and clean, and it reduce health issues and also tourist people can live properly in Pondy.

- **Community park transformation**

Social work trainee found that the community park near Janani home was a hub of drug addicts and many people were using the park to dump their garbage, so the trainee took initiative and cleaned the park with the help of the community people and MLA of the Oupalam Legislative constituency and also stick various poster in the park to aware the community people.

- **Casework session**

Social work trainee was able to practice one session of case work in the field. In this session the trainee establishes a rapport with the client and gathers basic details about the client and her problem.

- **Documentary**

Social work trainee noticed that the community park near the Janani home was being misused by dumping garbage and drug addicts, alcoholics were drinking there, the trainee made a documentary based on this issue.

- **Resource mobilization**

Social work trainee mobilized the resource for the dream home project (which is to buy the Janani homes rented building for the girl children who are staying there).

- **Christmas celebrations**

Social work trainee participated in three Christmas celebrations at different institutions of the NGO, one on December 16 at the Prime trust office for the children of Sishu Bhavan play school and the other two on December 21 and 23 at Janani home. And trainee were able to do cultural activity for the 16th and 23th programme and also trainee able to teach the children at Janani home various programmes like dance and speech for the Christmas celebration

- **Rearrange the library of the NGO**

Libraries are the room full of knowledge so, social work trainee rearranged and organized the existing library of the NGO.

- **Medical camp**

Social work trainee volunteered the medical camp done by Prime trust in hands with Dr. Agarwals eye hospital, Equitas development initiative trust and “Keep Namma Pony Clean” at Ellaipillaichavady community-park, for the sanitation workers from 1:00 pm to 2:45 pm.

- **Remedial school**

Social work trainee assisted the teachers in all the three remedial schools by teaching the students for improving their studies

- **Social media promotion**

Social work trainee did promotion work of the Ngo in various social media such as you tube, Google, online sites, etc.

- **Collect the profile of the agency**

Trainee collected the information related to the Ngo from programme coordinator Mrs. Mary Slessor and understood their Projects, administrative structure, history etc.

OBSERVATIONS

- Social work trainee observed the working of the Ngo that office hours of the Ngo are 9:00am to 5:30pm and also Sunday is not a working day.
- Social work trainee observed the various projects of the agency, it include Janani home for girls, remedial schools, shishu bhavan daycare centers, child sponsorship...etc. So trainee understood that they are mainly focused on upliftment of women and children
- Social work trainee observed the lack of community sanitation and a lot of stray dogs are walking through the streets, it reduce the safety of people
- Social work trainee observed the importance of promoting an Ngo in social media , it will help for resources mobilization.
- Social work trainee observed that there are mainly three remedial schools working under the Ngo one at Janani home and others are Shishu bhavan evening schools and evening tuition center.
- Social work trainee observed that their main project Janani home provide a lot of help for the poor children. They provide food, accommodation, vocation training, educational facilities, medical care and other services for the children.
- Social work trainee observed that the surroundings of the Janani home was not clean.
- Social work trainee observed how they maintain their files and also the importance of those files.
- Social work trainee observed how the awareness classes help the children to get more Knowledge about human rights.
- Social work trainee observed how the workshop programme help the children to make Posters and also the how creative they are.
- Social work trainee observed that some people at the slum area near by are very dangerous and other community people are afraid of them.
- Social work trainee observed that how the rally help to aware the community people
- Social work trainee observed how a professional planning takes place and how it help to take a creative ideas and decisions

- Social work trainee observed the importance of team work.
- Social work trainee observed that every profession have its own problems and it will be Fine when we started to face those problems
- Social work trainee observed medical camps are really important in a community, a lot of people may don't aware they have health issues, through these kind of medical camp they can aware of their heath issues and they can take proper treatment for that.
- Social work trainee observed that fund is very important for working of an Ngo, without financial support we can't run an Ngo.
- Social work trainee observed that children's at Janani home, Shishu bhavan school and tutuion center are very talented
- Social work trainee observed the political support of a programme while doing shramadhan,
- Social work trainee observed how the community people treat a public place, they treat public place as a dumbing ground.
- Social work trainee observed that the reports of various activities done by the NGO
- Social work trainee observed the importance of idea sharing while working as a group.
- Social work trainee observed how to write project proposal
- Social work trainee observed the importance of principle of confidentiality while doing case work
- Social work trainee observed documentary and pasting posters raise awareness effectively

- Social work trainee learned about the Janani home, it is a hostel for poor girls and also they provide food, accommodation and other services.

- Social work trainee learned to take classes for students, how to teach them in their academics
- Social work trainee learned to take awareness class and also learned how to do workshop.
- Social work trainee learned how to conduct day observation by doing various activities such as rally, awareness classes
- Social work trainee learned how to conduct rally for observing a day and also how the rally help the community people to aware about Human rights.
- Social work trainee learned how to involve the community for their own development
- Social work trainee learned how to write project proposal
- Social work trainee learned how a professional team work takes place and also learned the importance of team work while working as a team.

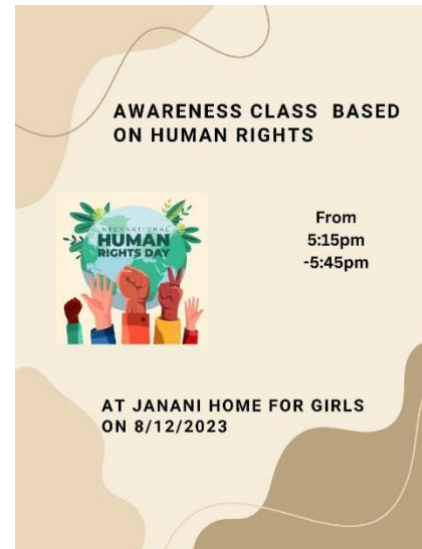
EVALUATION

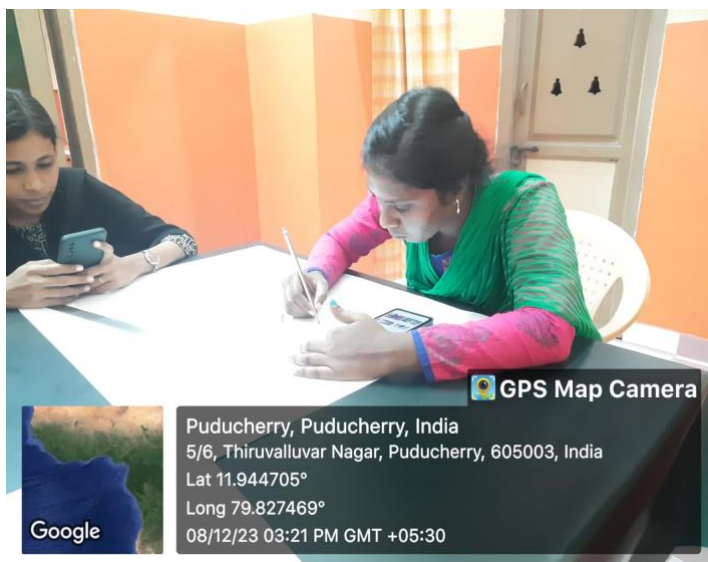
CONCLUSION

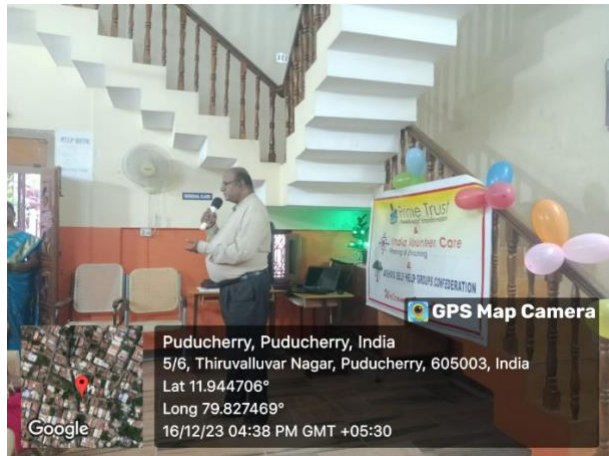

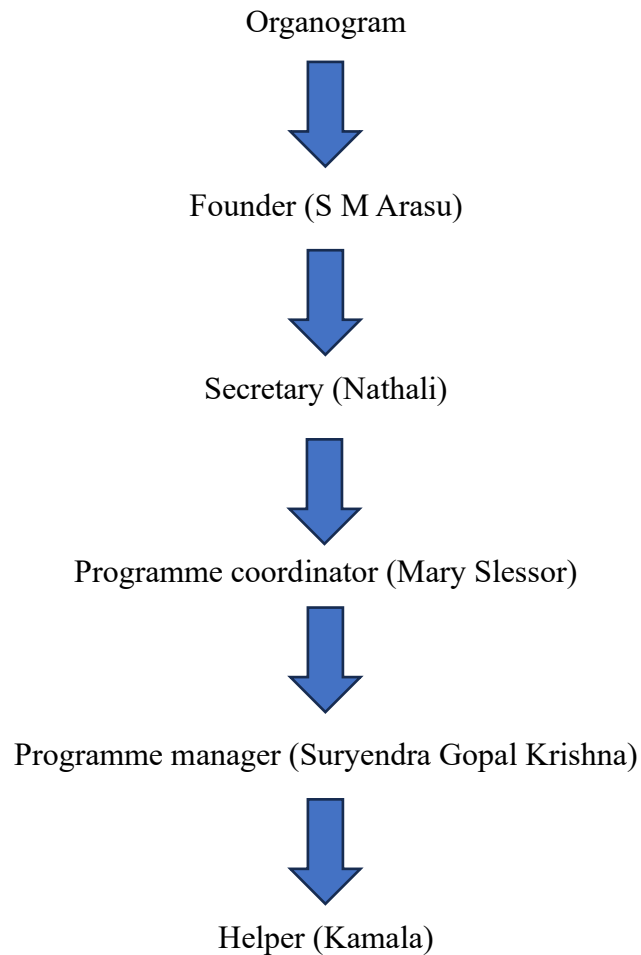
