Minutes of the meeting held on 10th December 2024 at 12:00 pm in the conference hall

Agenda:

- 1. To discuss the ragging preventive measures to be adopted in the campus during the academic year
- 2. To discuss about the orientation on anti-ragging to be given to the I DC students during the student induction programme.
- 3. To consider any other matter for discussion which is put forward in the meeting.

Decisions Made:

- 1. An orientation on anti-ragging measures on campus and the mechanism for registering grievances via the college website portal was provided to the first-year undergraduate and postgraduate students. The session included information on students' rights, how to approach the grievance cell, and the importance of mutual respect among peers.
- 2. Orientation talks were conducted in both the men's and women's hostels, focusing on the legal and disciplinary consequences of ragging, the significance of fostering a welcoming environment, and steps for anonymously reporting incidents.
- 3. A strict warning was issued to students regarding the disciplinary actions that would be taken by the authorities in case of any reported incidents of ragging. The warning emphasised the institution's zero-tolerance policy towards ragging, as per UGC and state government regulations.
- 4. As part of the induction programme for first-year undergraduate students, the Dean of Faculty & Student Affairs, Dr. Anilkumar N., delivered a talk on antiragging measures. The session covered the moral, ethical, and legal dimensions of ragging, highlighting the consequences for both perpetrators and victims.
- 5. All formalities related to addressing institutional complaints about ragging were completed, ensuring compliance with UGC and government regulations. The grievance redressal system was streamlined to facilitate swift action on any complaints received.

- 6. From the next academic year onwards, it was decided to extend the anti-ragging orientation to second-year undergraduate and postgraduate students. This decision was made to reinforce awareness and encourage senior students to take an active role in preventing ragging.
- 7. Notices stating that ragging is an offence and a punishable crime were affixed to the walls on all floors of the campus. The notices included relevant legal provisions, helpline numbers, and the institutional mechanisms available for addressing grievances. All displays were prepared in accordance with UGC guidelines to maximise awareness.
- 8. Visits were conducted by college authorities, in collaboration with the excise department, to off-campus accommodations where students reside as paying guests, even if not under the direct control of the college. These visits aimed to ensure the safety and well-being of students and to discourage any form of misconduct. It was decided to continue this practice as part of the institution's commitment to a ragging-free environment.
